KNOW ALL MEN BY THESE PRESENTS: That the undersigned, an adult citizen of the United States and resident of the State of Idaho, does hereby establish Group 7 Development, Inc., as a corporation under the provisions of Chapter 1, Title 30, Idaho Code, and in furtherance of said purpose does hereby certify:

1. Name. The name of the Corporation is Group 7 Development, Inc.
2. Purposes. The Corporation is established for the purpose of conducting any and all business that may be conducted by or on behalf of corporations in the State of Idaho.
3. Duration. The Corporation shall have perpetual existence.
4. Authorized shares. The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares of the par value of \$1.00 each, all of one class, which shall be designated common stock.
5. Registered office and agent. The address of the initial registered office of the Corporation is 10030 Mallard Drive, Nampa, Idaho 83686. The name of the initial registered agent at such address is Mark Summers.
6. Directors. The management of the affairs of this Corporation shall be vested in the Board of Directors. The Board shall consist of three (3) directors. No person


