ARTICLES OF INCORPORATION $\circ f$

MEISER INDEFENDENT MEAT LARRIET, INC., a Correpation

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, full age citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a private corporation under and pursuant to the Laws of the State of Idaho, and we do hereby set forth and declare as follows:

That the name of this corporation is and shall be "Weiser Independent Meat Market, Inc., "a Corporation;

That the purposes for which said corporation is formed

To conduct and carry on a general business dealing with livestock and meat, to buy, raise, feed and process for gain, resell (retail or wholesale) over the counter or to customers or both. To do custom cutting and killing. To warehouse any commodity that housing facilities may demand. To buy, sell, lease or exchange real and personal property, and to acquire machinery, fixtures, appliances, furniture and other materials as this corporation may deem necessary tocarry into effect the purposes of its organization; and to sell, convey, lease, assign, mortgage or otherwise encumber or dispose of any and all real and personal property, and to do and to perform all such acts and things as maybe requisite and necessary in the premises to engage in a general merchandising business;

III.

That the term for which said corporation is to exist is unlimited and indefinite from and after the date of its incorporation;

IV.

That the principal place and office for the transaction of the business of this corporation is located at 33 East Idaho Street, Weiser, Washington County, Idaho;

That the amount of the authorized captial stock of this corporation shall be One hundred thousand (\$100,000.00) dollars, divided into Ten thousand (10,000) shares of Common Stock of the par valus of Ten (\$10.00) per share. Each share of stock shall be entitled to one vote on all matters, and no preferences and restrictions are granted to or imposed upon the shares of stock; such stock may be issued by the corporation from time to time for such cause as maybe fixed by the Board of Directors thereof;

VI.

That the corporate powers of the corporation shall be vested in the Board of three(3) Directors for the first year of the life of this corporation and until their successors are elected and qualified. The first Board of Directors and their residences are as follows:

That hte persons named above shall constitute the Directors of the corporation until changed by amendment of the By-Laws increasing or decreasing the number of directors as maybe desired in the manner provided by law.
