ARTICLES OF AMENDMENT

OF

IDAHO YOUTH SOCCER ASSOCIATION

At a meeting of the members of the Idaho Youth Soccer Association convened the 12th day of April, 1979, for the purpose of amending the Articles of Incorporation of the Idaho Youth Soccer Association, duly called upon notice of the specific purpose, the following Amendments to the Articles of Incorporation was adopted by the holders of 2/3 of the voting power of all members of the Association:

Resolved that:

Article VI of the Articles of Incorporation of the Idaho Youth Soccer Association be amended to read as follows:

ARTICLE VI

Purposes

This corporation shall not carry out any activity which will result in a pecuniary profit to its members. The corporation is organized exclusively for charitable and educational purposes within Section 501(c)(3) of the Internal Revenue Code, and notwithstanding any other provision of these Articles shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. Subject to the foregoing limitation, the

object, business or pursuit of this corporation shall be as follows:

- (a) To develop, promote and administer soccer competition among youths 18 years of age or younger in the state of Idaho.
- (b) To promote and encourage public understanding of the game of soccer.
- (c) To procure, produce, issue, distribute or otherwise handle informative bulletins, pamphlets, films, slides, or any other communicative media designed to promote, train, educate and stimulate interest in the game of soccer.
- (d) To receive gifts and grants of money and property of every kind and to administer the same for the purposes designated above.
- (e) To do everything necessary, proper, advisable or covenient for the accomplishment of any of the purposes, or the attainment of any of the objects herein set forth, either alone or in association with others, and incidental or pertaining to, or growing out of, or connected with, its business or powers, provided the same be not inconsistent with the laws of the State of Idaho.
