

**Amended and Restated Articles of Incorporation
(Non-Profit Religious Corporation No.27483)**

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned ~~non-profit~~ corporation amends and restates its articles of incorporation as follows: AM 8:58

1. The name of the corporation is Bethel Baptist Church, Inc.
2. The text of each amendment and restatement is as follows:

Article 1: Name

The name of the corporation is Mountain Lakes Bible Church, Inc.

Article 2: Purpose

The purpose for which the corporation is organized is:

1. Promoting the doctrines and teachings of the Bible and Christ Jesus.
2. Providing education and training.
3. Owning and maintaining suitable real estate and buildings.
4. Providing for its members a place to worship, education and training.
5. Receiving, holding and disbursing gifts, bequests, devises, and other funds.
6. Doing all things supporting, or necessary and incident thereto.

Article 3: Registered office address

The street address of the registered office is: 2215 North Seventh Street, Coeur d'Alene, Idaho 83814, Kootenai County and the registered agent at such address is Sabrina Porath.

Article 4: Board of Directors

Providing the board of directors consists of no less than one person, the constitution or bylaws may prescribe the manner to increase or decrease the number of directors from time to time. The names and addresses of the current directors are:

Article 7: Dissolution

Upon dissolution, the assets shall be liquidated to pay all creditors. What is remaining after satisfying all creditors will be distributed among the non- profit organizations which meet the meaning of Section 501 (c) (3) of the Internal Revenue Code that our current supported missionaries are affiliated with at the time of dissolution to continue their support. The list of the non- profit organizations that our current supported missionaries are affiliated with at the time of dissolution shall be maintained by the Church secretary and filed in the Church office

3. The date of adoption of the amendments and restatements was: 4-2-2006
4. The amendments and restatements consist of matters other than those described in section 30-3-90, Idaho Code, and was, therefore adopted by the members.
 - a. The number of members entitled to vote was: 58
 - b. To have a quorum, 20% or more of members entitled to vote need to be present. $20\% = 12$.
 - c. The number of members present entitled to vote was: 40
 - d. The number of members that voted for each amendment and restatement was: 37.
 - e. The number of members that voted against each amendment and restatement was: 2.
 - f. To have the amendments and restatements adopted 75% or more of the members present entitled to vote has to vote for. $75\% = 30$.
