ARTICLES OF INCORPORATION

OF

ROBBERS ROOST AGRICULTURAL COMPANY NO. 13
STATE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age, citizens of the United States and residents of the State of Idaho, this day have voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I

The name of this corporation shall be Robbers Roost Agricultural Company No. 13.

ARTICLE II

The purposes for which this corporation is formed are:

(a) For agricultural purposes and to intensively farm small parcels of real property leased and owned.

(b) To grow or cultivate crops, including grazing, pasturage, agriculture, horticulture, floriculture, vitaculture and nurseries, fruit trees, Christmas trees, berry bushes and the necessary assessorary uses for the packing, treating or storing of the produce; and the raising of domestic livestock and poultry, and the growing and cultivation of all forest crops.

(c) To engage in agricultural pursuits as indicated above for the purpose of increasing the agricultural production and capacity of the State of Idaho.

(d) To purchase, acquire, own, hold, lease (either as lessor or as lessee), sell, exchange, subdivide, mortgage, assign and generally operate any real or personal property of any and every kind or description within the State of Idaho, necessary, suitable, or useful in connection with any of the objects or purposes herein set forth;

(e) To build, construct, lease or otherwise acquire, maintain, own, utilize and operate buildings, storage houses and garages for the purposes of carrying on the business of the corporation;

(f) To construct and erect buildings or structures upon and to improve and maintain, cultivate and operate any and all real property owned, leased or held by this corporation; and to equip, improve and generally operate any and all personal property owned by this corporation;

(g) To borrow money for any purpose of this corporation without limit as to amount, and to issue bonds, debentures, notes or other evidences of indebtedness, secured or unsecured, of this corporation for the moneys so borrowed, or in payment for property acquired, or for any other objects or purposes of this corporation, or in connection with its business;

(h) To investigate, develop, consummate, undertake or carry on any enterprise, business, transaction or operation of any financial, commercial, industrial, agricultural or other nature, calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho;

(i) The object as specified herein shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clauses or paragraphs in these articles shall be regarded as independent objects, purposes and powers.

ARTICLE III

The existence of this corporation shall be perpetual.

ARTICLE IV

The principal place of business of this corporation shall be at 407 West Jefferson, Boise, Idaho, 83702.

ARTICLE V

The total amount of authorized capital stock in this corporation is \$5,000, consisting of 5,000 shares of common stock with a par value of \$1 per share.

ARTICLE VI

The members of the governing board of this corporation are styled "Directors," and the Board of Directors shall consist of 3 persons.

ARTICLE VII

The capital stock of this corporation shall be non-assessable; and the private property of the shareholders, and each of them, of this corporation shall not be subject to assessment or be liable for the debts, obligations, or liabilities of this corporation.

ARTICLE VIII

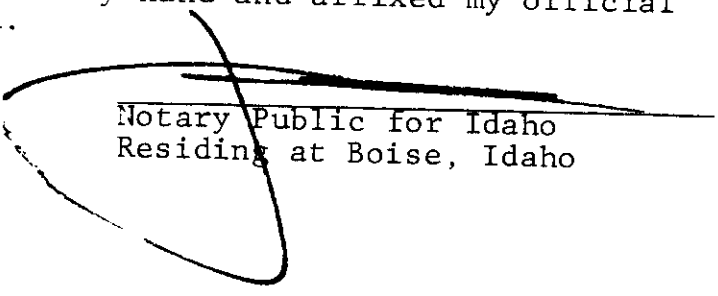
