ARTICLES OF INCORPORATION  
OF  
LAKE LEASING CO.

I. NAME

The name of the corporation is LAKE LEASING CO.

II. PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the California Corporations Code.

III. AGENT FOR SERVICE OF PROCESS

IV. STOCK

The corporation is authorized to issue only one class of shares which shall be designated "common shares," having a total number of Five Hundred (500,000) shares.

V. NO PREFERENCES, PRIVILEGES, RESTRICTIONS

No distinction shall exist between the shares of the corporation or the holders thereof.

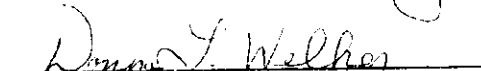
VI. GRANT OF PREEMPTIVE RIGHTS
