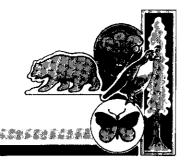

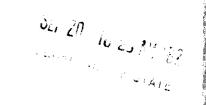

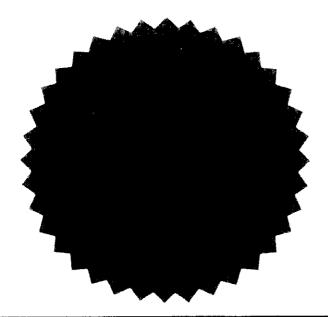

I. NAME

The name of the corporation is LAKE LEASING CO.
