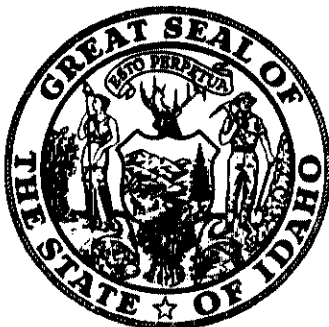
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION  
OF  
ETERNA-LINE DUST ABATEMENT, INC.**

The undersigned, acting as Incorporator of ETERNA-LINE DUST ABATEMENT, INC., a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is ETERNA-LINE DUST ABATEMENT, INC.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act and as such may be amended.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) shares of common stock of a par value of \$1.00 per share, an aggregate total capital of ONE HUNDRED THOUSAND AND NO/100 DOLLARS (\$100,000.00).

**FIFTH:** Provisions denying preemptive rights are: There are no preemptive rights.

**SIXTH:** Provisions for the regulation of the internal affairs of the corporation are: The By-Laws shall set the number of and qualifications of Directors and Officers and shall set forth any restrictions, if any, on the transfer of shares.

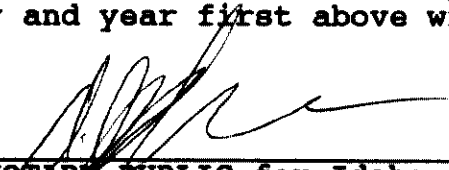
