ARTICLES OF INCORPORATION

OF

ELAM, BURKE AND BOYD, CHARTERED

The undersigned, acting as incorporator of a professional service corporation under the Idaho Professional Service Corporation Act, adopts the following Articles of Incorporation for this professional corporation:

I.

The name of this professional corporation shall be Elam, Burke and Boyd, Chartered.

II.

The period of existence and duration of the life of this professional corporation shall be perpetual.

III.

The location of the registered office of this professional corporation is 702 West Idaho, Boise, Idaho 83701, and the name of the initial registered agent at such address is William J. Batt.

IV.

The nature of the business and the sole object and purpose of this professional corporation shall be as follows:

To engage in every phase and aspect of the business of rendering the same professional services to the public that attorneys, duly licensed under the laws of the state of Idaho, are authorized to render, but such professional services shall be

rendered only through officers, employees, and agents duly licensed under the laws of the state of Idaho to practice law therein.

٧.

The total number of shares of this professional corporation shall be 10,000, each of a par value of \$1.00, which shares shall be common stock and shall not be subject to assessment. None of the shares of this professional corporation shall be issued to anyone other than an individual duly licensed to practice law in the state of Idaho.

VI.

No shares shall be transferred except to an individual who is eligible to be a shareholder of this professional corporation, and such transfer may be made only after the same shall have been approved, at a stockholders' meeting specifically called for such purpose, as provided in the By-laws. At such shareholders' meeting, the shares of stock held by the shareholder proposing to sell or transfer his shares not be voted or counted for any purpose, unless all stockholders consent that such stock be voted. No shareholder of this professional corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.
