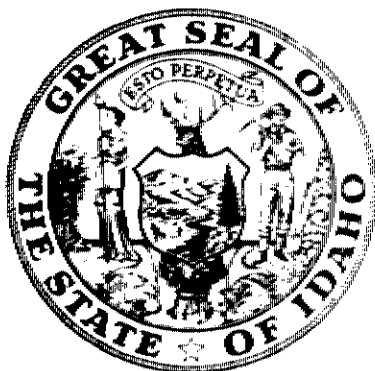

ARTICLES OF INCORPORATION

of
