

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF  
LAND TITLE COMPANY, INC.

THE UNDERSIGNED, Dwain H. Stufflebeam, President, Charles C. Just, Vice President, and Joyce L. Stufflebeam, Secretary, of LAND TITLE COMPANY, INC., an Idaho Corporation, do hereby certify and respectfully represent as follows:

That on March 18, 1980, a special meeting of the stockholders of Land Title Company was held pursuant to 25 days written notice for the purpose of voting on an amendment to the By-Laws and Articles of Incorporation to change the name of the corporation and increase the Capitol Stock of the corporation. At that meeting the following resolution to amend the Articles of Incorporation was unanimously adopted by all of the stockholders of the corporation. All of the stockholders being present and voting:

RESOLVED That Article I and Article V of the Articles of Incorporation of Land Title Company, Inc., an Idaho Corporation be amended to read as follows:

ARTICLE I

The name of the corporation shall be First American Title Company of East Idaho.

ARTICLE V

The amount of the total authorized stock of this corporation shall be \$1,000,000.00 divided into 100,000 shares of \$10.00 par value each of common non assessable stock, and the rights appertaining thereto will be in all respects equal and the shares may be increased or decreased as provided by the laws of the State of Idaho.


At the stockholders meeting on March 18, 1980, there were 2,500 stock of stock outstanding and 2,500 shares of stock entitled to vote at said stockholders meeting.

That at said stockholders meeting 2,500 shares of stock was voted in favor of the foregoing amendments and that no votes were cast against such amendments.


