ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, A. MARIE MC DOUGALD, DANIEL WILL MC DOUGALD and DANIEL C. MC DOUGALD being of full age and citizens of the United States of America, have associated themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and in pursuance thereof, do hereby sign and acknowledge the following Articles of Incorporation in triplicate originals and so state as follows:

I.

That the corporate name of this corporation shall be FLY AWAY TRAVEL, INC.

II.

That the primary purpose for which this corporation was formed is as follows:

To engage in rendering travel consulting, ticket procurement services and hotel and resort reservations for and to government agencies and the private sector, including all activities related to the travel agency business, so as to assist customers in effective travel buying decisions, all with emphasis on time management, cost control and quality results.

In addition the corporation shall have authority to engage in any activity supplemental or complementary to the primary purpose herein, including any lease, purchase, or rent of land or personal property, and to do everything suitable and convenient or necessary to carry out the purposes herein.

To apply for, purchase, acquire, grant, sell, assign or otherwise deal in and use patents, rights, privileges, securities, licenses, franchises, trademarks, copyrights and any or all processes of every sort and description.

To manufacture, buy, sell, export, and import goods and merchandise of every class and description.

To exercise all or any of its corporate powers and rights in the State of Idaho, other states, and territories of the United States, and in foreign countries, but only in compliance with the respective laws thereof.

To do everything necessary, proper, advisable or convenient for the accomplishment of any of the purposes or objects herein, provided same be not inconsistent with the laws of the State of Idaho.

The purposes and powers herein are not limited or restricted by reference to each other, but each may be considered independently; however, the powers and purposes are in furtherance of the powers granted by the State of Idaho, and not in limitation thereof.

III.

The corporation shall have perpetual existence and will commence business with paid in capital of TWO THOUSAND (\$2,000.00) DOLLARS.

IV.

The registered office of the corporation, and its post office address shall be Fly Away Travel, Inc., 1956 W. Pullman Rd., Moscow, Idaho 83843. The Registered Agent shall be DANIEL WILL MC DOUGALD.

V.

That the total authorized number of common shares shall be FIFTY THOUSAND (50,000) each of par value of ONE DOLLAR (\$1.00) constituting an authorized capital stock of FIFTY THOUSAND DOLLARS (\$50,000.00). All of the stock shall be common stock and the relative rights concerning said stock shall be equal and the holders thereof shall be entitled to one vote for each share of stock held by them.

VI.

That the number of directors of this corporation shall be not less than two (2) nor more than five (5), that the number, qualifications, terms of office, manner of elections, time and place of meeting, and the powers and duties of the directors shall be such as are prescribed by the By-Laws of this

corporation; that the names and post office addresses of the initial directors who shall hold office and manage the affairs of the corporation, who shall hold office for a period of one year after its incorporation, are as follows:
