ARTICLES OF INCORPORATION

of.

BOUNDARY COUNTY LICENSED BEVERAGE DEALERS, INC.

an Idaho Corporation

KNOW ALL MEN BY THESE PRESENTS:

That we, whose names are hereto affixed, all of whom are bonafide residents and full-age citizens of the United States of America and of the State of Idaho, do under and in pursuance of Idaho Code 30-301 et seq. of the Idaho Code as amended, and general corporation laws of the said State, hereby organize, constitute and associate with us in accordance with these Articles into a body politic, and corporate for the purpose hereinafter set forth, and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

NAME

The name of this corporation is BOUNDARY COUNTY LICENSED BEVERAGE DEALERS, INC.

II.

PURPOSES

The purposes of this organization shall be:

- To promote the licensed beverage business in the County of Boundary, State of Idaho, foster good will and fellowship amongst the holders of licensed beverage establishments.
- 2. To promote the adoption and the application of higher social, business, and professional standards.

- 3. To do all such things as are incidental or conducive to the attainment of the above project.
- 4. To be a fraternal and benevolent corporation for the welfare of the general public.
- 5. To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform so long as in conformance with the other puposes herein enumerated.
- 6. To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering and generally dealing in real and personal property so long as in conformance with the other purposes herein enumerated.
- 7. The purposes herein shall be constructed both as purposes and powers and shall be in nowise restricted or limited by reference to, or inference from, the terms of any other clause in this or any other Article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature unexpressed.
- 8. To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or pertinent to or growing out of or connected with the aforesaid objects and purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and also so long as in conformance with the other purposes herein enumerated.

III.

DURATION

The duration of the corporation is perpetual.

IV.

LOCATION

The location is Boundary County, State of Idaho; and the post office address of the registered office of the corporation is P.O. Box 328, Bonners Ferry, Idaho 83805.

Fredericka Florea of the same address is the statutory agent.

V.

MEMBERSHIP

Any person shall be eligible to membership who qualifies under requirments as set forth from time to time in the By-Laws. The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member and shall be on one class of membership.

VI.

DIRECTORS

The corporate powers of this corporation shall be vested in a Board of at least $\underline{\text{two }(2)}$ Directors, to be elected as provided in the By-Laws of this corporation. To be a director a person must be a member. The powers and duties of the officers of this corporation shall be as prescribed in the By-Laws.
