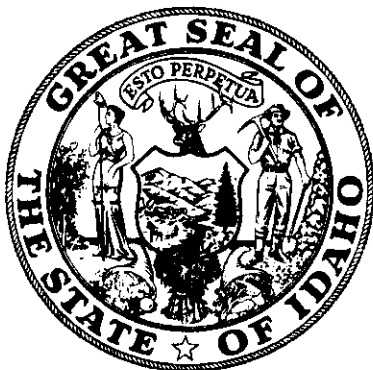

ARTICLES OF INCORPORATION  
OF  
BARNARD CONSTRUCTION, INC.

THE UNDERSIGNED, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the General Corporation Law of the State of Idaho, hereby certify as follows:

1. The name of the corporation is BARNARD CONSTRUCTION, INC.
2. The existence of the corporation is to be perpetual.
3. The purpose of the corporation is to carry on any or all lawful business not forbidden by the Corporation laws of the State of Idaho, and with all the powers conferred upon corporations by the laws of Idaho.
4. The corporation is authorized to issue capital stock to the extent of 100,000 shares at a par value of \$.10 per share.
5. Transfer of ownership (represented by shares of stock) in corporation is prohibited without first offering to the Corporation the opportunity to reacquire the stock.

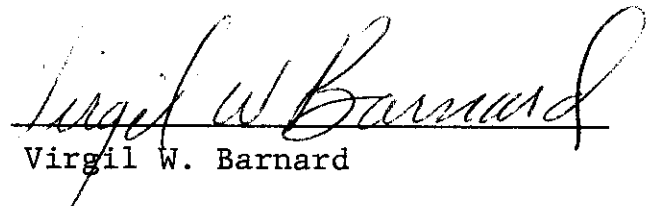
