ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
of

PREMIUM PRODUCE, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Premium Produce, Inc.

SECOND: The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on October 23, 1986. The name of the corporation was changed from "Premium Produce, Inc." to "The Pride of Idaho, Inc." by amending Article I of the Articles of Incorporation to read as follows, in the manner prescribed by the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

THE PRIDE OF IDAHO, INC.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 600 shares of common stock of one class only; and the number of shares entitled to vote thereon was 600 shares.

FOURTH: The number of shares voted for such amendment was 600; and the number of shares voted against such amendment was 0.
