ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME. The name of the corporation is:

MONA LISA'S, INC.

ARTICLE II.

<u>DURATION</u>. The corporation shall exist perpetually or until dissolved according to law.

ARTICLE III.

<u>PURPOSES</u>. The purposes for which the corporation is organized are:

- To engage in all aspects of preparing Food and/or Beverage and/or retail selling of Food and Beverage products to the public, contractors, and any other person or entity.
- 2. The corporation shall have all powers, allowed by the bylaws and any and all powers and purposes it deems necessary so long as lawful.

3. The purposes stated herein shall be construed as powers as well as purposes, and the matters expressed in any clause shall not be limited by reference to or inference from the terms of any other, but shall be regarded as independent purposes and powers; and the enumeration of specific purposes and powers shall not be construed to limit or restrict the meaning of general terms of the general powers; nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature.

ARTICLE IV.

CAPITALIZATION. The aggregate number of shares which the corporation shall have the authority to issue is one hundred and twenty million (120,000,000) shares of stock which stock shall be of one class only which shall be common voting stock possessing a par value of one cent (\$0.01) per share, non-assessable.

ARTICLE V.

<u>PAID IN CAPITAL</u>. The corporation will not commence business until consideration of the value of at least one thousand dollars (\$1000.00) has been received for the issuance of shares.

ARTICLE VI.

BYLAWS. Provisions for the regulation of all of the affairs of the corporation shall be set forth in the Bylaws which shall be adopted and followed. Changes in the Bylaws can only be made upon the approval of a majority of the shares outstanding of the then issued and outstanding capital stock of the corporation.

ARTICLE VII.
