ARTICLES OF INCORPORATION

of

BONNEVILLE BLUEPRINT SUPPLY, INC.

We, the undersigned, citizens of the United States of America and residents of the State of Idaho, have, and by these presents do, associate ourselves together as a body corporate, and to that end do, adopt, declare, publish, and certify the following Articles of Incorporation:

Ι.

That the name of the corporation shall be: BONNEVILLE BLUEPRINT SUPPLY, INC.

II.

That the purposes for which this corporation is formed are:

- A. To buy, sell and distribute at wholesale and retail, office equipment, reproduction machines and equipment, copying devices and equipment, vending machines, office supplies, school supplies, audio-visual equipment and supplies, engineering and other technical equipment and supplies, dental chairs, equipment and supplies, architectural equipment and supplies, recording equipment and supplies, photographic equipment, materials and supplies, accounting equipment and supplies, books, records and ledgers, and electronic equipment, machines and supplies, for profit.
- B. To manufacture and deal in merchandise and other property of every nature or description pertaining, but not limited to, office, dental, educational, engineering, photographic, architectural and accounting equipment, machines, and its accessories, including their manufacture, production and services therefor.
- C. To construct and place, service and repair, all of the foregoing types of equipment and machines.

- D. To offer and engage in consulting services, demonstrations, seminars and business meetings with respect to all said equipment, devices, aids, materials or supplies herein.
- E. To manufacture, distribute, sell, lease or otherwise deal in any and all kinds of related machinery, equipment, and useful devices, and to engage in any and all related activities and operations consistent with the purposes set forth herein.
- F. To receive, acquire, hold, purchase, dispose of, convey, mortgage, and/or lease real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.
- G. To conduct business in this state, other states, District of Columbia, territories and colonies of the United States, and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.
- H. To do all acts permitted by the General Business Corporation Act of the State of Idaho, and all other acts that are necessary and expedient to accomplish its stated purposes.
- I. In addition to all of the acts in H. above, to possess all powers, rights and privileges necessary or incidental to the objects or purposes for which this corporation is formed, and to the activities in which it is engaged, or which would further the accomplishment of such objects, purposes or activities.

III.

The term of existence of this corporation is perpetual.

The location and Post Office address of the registered office of this corporation in the State of Idaho shall be the City of Idaho Falls, County of Bonneville, State of Idaho.

٧.

The amount of the capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00), divided into five hundred (500) shares of the par value of One Hundred Dollars (\$100.00) per share, to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine.

The transfer of the capital stock in this corporation shall be restricted in accordance with a provision appearing on the certificates of capital stock, reading as follows:

No transfer of this certificate or the stock represented thereby shall be valid until thirty days after the corporation through its secretary shall have written notice of the purposes of sale, the number of shares proposed to be sold, and the name of the prospective buyer; and during said days, the corporation shall have the option to buy at the book value at the close of the last fiscal year, any shares of outstanding stock so proposed to be transferred.

VI.

All shares of stock shall be classified as common stock.

VII
