know all MEN BY THESE PRESENTS; That we, the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify;

T.

That the name of this Corporation is "CENTRAL PARK LADIES AID", of Central Park, Can'on County, Idaho.

II.

That the purposes for which it is formed are: To conduct and marintain religious worship, to hold meeting of general interest to the community, and to acquire and hold such real and porsonal property as may be necessary, convenient and advantageous for the conduct and maintenance of religious worshop and for holding meetings of general interest to the community, and to mortgage and dispose of the same in the manner conducive to the corporation and the purposes for which it is formed.

III.

That the principal place of business is to be transacted shall be Central Park, Canyon County, State of Idaho.

IV.

That the term for which it is to exist shall be fifty years from and after the date of its incorporation.

٧.

That the number of directors shall be three, each of whom is to serve for a term of one year, or untill her or his successor is elected and qualified; provided, however, that a vocancy may be declared in the office of director by a majority
