ARTICLES OF INCORPORATION

OF

CAPITAL ALIGNMENT, INC.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is CAPITAL ALIGNMENT, INC.
(hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in AUTO ALIGNMENT & BRAKE REPAIR; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be 5015 FAIRVIEW AVE, BOISE, ID 83704, and the name of its initial registered agent at such address is NORMAN MATLOCK.

ARTICLE V
