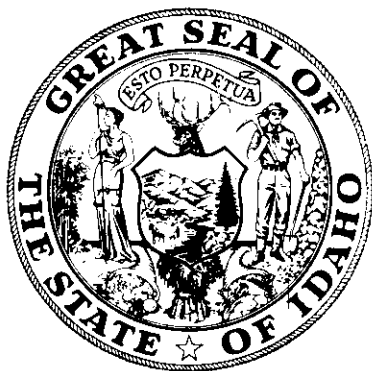

ARTICLES OF INCORPORATION

of

AGRA-DATA SYSTEMS, INC.

Pursuant to the provisions of Section 30-1-58 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Agri-Data Systems, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on November 26, 1982, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I

The name of the corporation is to be changed to Agri-Data Systems, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1100 and the number of shares entitled to vote thereon was 1100.

FOURTH: The number of shares voted for such amendment was 1100 and the number of shares voted against such amendment was none.

FIFTH: The manner in which any exchange, reclassification, or cancellation of issued shares provided for in the amendment shall be effected is as follows:

All shares were to be cancelled and the following issued under the amended name of Agri-Data Systems, Inc.:
