ARTICLES OF INCORPORATION

OF THE

We the undersigned, for the purpose of forming a non-profit corporation under and pursuant to Title 30, Chapter 3, Section 323 of Corporation Laws of the State of Idaho, 1979, and amendments thereof, do hereby associate ourselves a non-profit organization, and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be THE OPEN UNIVERSITY, INC.

ARTICLE II

The purpose of this corporation shall be to provide a forum for the sharing of skills amongst community members which enhances personal growth and enjoyment and improves the quality of life in our community.

For the accomplishment of this purpose, the organization will accept donations of capital, goods, services, or property.

At its discretion it may also deem it appropriate to hold fund raising activities, and may perform such further acts as are necessary and convenient to capitalize, and maintain its interests and property.

All acts being not contrary to law.

ARTICLE III

Existence of the corporation shall be perpetual.

ARTICLE IV

ARTICLE VIII
