

## ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned, a majority of whom are freeholders, citizens and tax payers of the State of Idaho, have this 7th day of Feb., 1903, voluntarily associated ourselves together for the purpose of forming a corporation under the laws of Idaho.

### AND WE HEREBY CERTIFY

1st. That the name of the said corporation shall be the East Branch Canal Co.

2nd. That the purpose for which it is formed, is to have and to hold real estate, and personal property, to construct a canal system and all works appurtenant thereto. To construct head gates, dams and ditches, to put in bridges, boxes and for all other purposes necessary for irrigation and agricultural pursuits, and for the purpose of generating power for mills and electricity.

3rd. That the principle place of business of said corporation shall be at Bench, Idaho.

4th. That the term for which said corporation is to exist is to be <sup>50</sup>~~25~~ years from and after date of its incorporation.

5th. That the number of directors, or trustees of said corporation shall be five, and the names of the board of directors, or trustees who are appointed for the first year, a majority of the members being present and voting; and to serve until the election and qualification of their successors are as follows, to wit.

F. C. Christensen of Bench, Idaho.

J. W. Hubbard of Bench, Idaho.

Josiah Bannister of Hanna, Idaho.

S. A. Egbert of Grace, Idaho, and

Edward Kirby of Grace, Idaho.

6th. That the amount of the capital stock of said corporation is Ten Thousand shares of the par value of one dollar each.

7th. That the amount of capital stock which has been actually subscribed is Three Thousand eight hundred and forty six dollars, \$3846.00. And the following named persons with the amounts set opposite their names is the amount subscribed by each.
