ARTICLES OF INCORPORATION  
OF CHLORIDE EUREKA COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, one of whom at least, is a bona fide resident of the State of Idaho, do hereby associate ourselves as a body politic and corporate, under and by virtue of the Constitution and Laws of the State of Idaho, being the Compiled Statutes of Idaho, and all acts amendatory and supplemental thereof and thereto.

First. The name of this corporation shall be CHLORIDE EUREKA COMPANY.

Second. The objects and purposes for which this corporation is formed are as follows: To engage in the business of mining, smelting, refining, reducing and dealing with all kinds of ores, metals and minerals, and the prospecting for, locating, opening, operating and developing of mineral ground and mineral deposits of all and every description, together with appurtenances that may be necessary and incidental thereto.

And generally in carrying on its business and for the purpose of opening or furthering its objects, to do any and all other things and exercise any and all other objects and purposes that are now or may hereafter be given it under the laws of this State.

Third. The place where the principal business of this corporation shall be transacted is Salmon, in the County of Lemhi, State of Idaho, but provision may be made in the bylaws of the corporation for holding meetings of its directors elsewhere.

Fourth. The term for which this corporation shall exist shall be fifty (50) years.

Fifth. The number of directors of this corporation shall be five.

Sixth. The acting directors of this corporation and the names and residences and offices of such who are to serve until the election of their successors, are as follows;

Seventh. The amount of the capital stock of this corporation shall be and is Five Hundred Thousand (\$500,000.00) Dollars, divided into five hundred thousand (500,000) shares of the par value of One Dollar (\$1.00) each.

Eighth. The amount of capital stock actually subscribed is three shares, amounting to \$3.00, and is subscribed by the following named incorporators, in the amount given opposite their respective names, to wit;

Ninth. The directors of this corporation shall be elected annually as may be provided by its bylaws.

Tenth. Without in any particular limiting any of the objects and powers of this corporation it is hereby expressly declared and provided that the corporation shall have power to issue bonds and other obligations in payment for property purchased or acquired by it for money borrowed or for any other object in or about its business, and to secure the same by mortgage or by any other security.

Eleventh. The stockholders shall not be individually liable for the debts and liabilities of the corporation.

Twelfth. In all other respects the corporation shall be governed and empowered to act by and in accordance with its bylaws and the laws of the State of Idaho as found in the Compiled Statutes of Idaho, and all acts amendatory thereof and supplemental thereto.

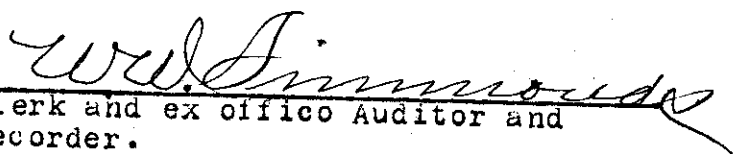
