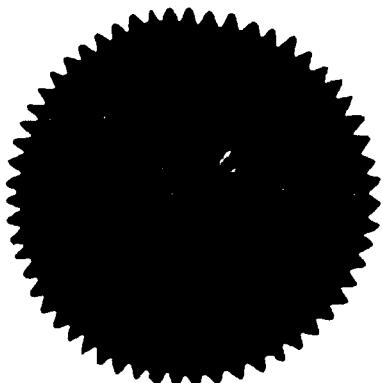

CERTIFICATE OF AMENDMENT

TO

CERTIFICATE OF INCORPORATION

Fenick & Ford, Limited, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY.

FIRST: That the Board of Directors of said Corporation, at a meeting duly held, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said Corporation:

RESOLVED, that the Certificate of Incorporation of the Company be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows:

FIRST: The name of the Corporation (which is hereinafter referred to as the "Company") is Empire, Inc.

SECOND: That in lieu of a meeting and vote of stockholders, the sole stockholder of said Corporation has given written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.
