ARTICLES OF INCORPORATION

OF

DRISCOLL FARMS, INC.

STATE

I.

I, the undersigned, being a natural person of full age, and a citizen of the United States, or of its territories or possessions, do hereby voluntarily form a private corporation, under the laws of the STATE OF IDAHO.

II.

The name of the proposed corporation is DRISCOLL FARMS, INC.

III.

The period of it's duration is perpetual.

IV.

The location and address of the registered office of this corporation shall be Route 1, Troy, Idaho 83871.

V.

The registered agent of the corporation shall be Dennis B. Driscoll, of Route 1, Troy, Idaho 83871.

VI.

The purpose of the corporation is the transaction of any or all lawful business for which corporations may be incorporated under this act.

VII.

The stock to be issued by this corporation shall be One Hundred Dollars (\$100.00) par value common stock. 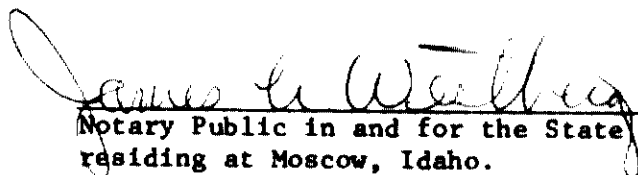
