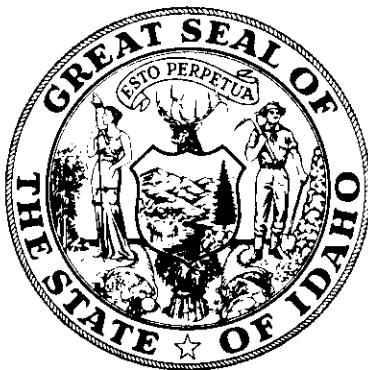

ARTICLES OF INCORPORATION

BASE⁴, INC.

ARTICLE I.

The name of the corporation shall be BASE⁴, Incorporated.

ARTICLE II.

The period of duration shall be perpetual.

ARTICLE III.

The purpose shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act : Title 30, Chapter 1.

ARTICLE IV.

The aggregatenumber of shares the BASE⁴, Inc. shall have the authority to let shall be 5,000,000. The shares shall consist of (1) class only of common stock, par value of one cent.

ARTICLE V.

Shareholders of this corporation shall have pre-emptive rights to acquire additional shares offered for sale by the corporation.

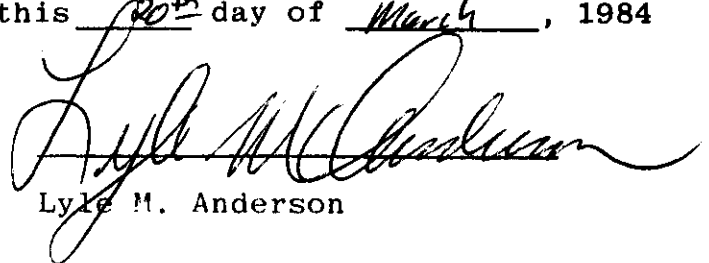
3. The term of the first directors shall be until the first annual meeting of the stockholders of the corporation to be held on March 1, 1985, and until their replacements are elected and qualified.
