
"BE IT RESOLVED that Article I of the Articles of Incorporation of Ace Printing, Inc., be amended so that it shall, as amended, read as follows:

'ARTICLE I.


That the name of the corporation is and shall be TIMES-NEWS-ACE PRINTING, INC.'."


