- other person, or property who will confer with said member prior to talking to law enforcement, or offering law enforcement a statement.
- 4. To educate members, who are in good standing within the rules and regulations of the organization, on the legal aspects of a justified use of a firearm and the ramification of such use.
- To provide specified member benefits, which may or may not change during the membership period, such as discounts on legal fees, bail procurement, and disaster cleanup.
- 6. To provided an additional voice for the protection of the Second Amendment to the United States Constitution, which provides for the private ownership of firearms.

### ARTICLE III.

That the educational aspect of this corporation shall be held online as well as through specially sponsored events by this corporation throughout the state of Idaho.
