## ARTICLES OF INCORPORATION

KNOW HALL CHEN BY THESE PRESENTS:

THAT THE INCORPORATORS who are GEENTH SCHOOL, ERIC K.
PETERSON and LOUANNA CLARK, citizens of the United States of
America, do form a non-profit corporation under and pursuant to
the laws of the State of Idaho, and do hereby certify as follows:

## FIRST

The name of the proposed corporation is GENIE FOUNDATION, INC..

#### SECOND

The period of duration for this non-profit corporation shall be perpetual.

## THIRD

The business and purpose of this Corporation shall be:

- a) to assist individuals in financing experimental and conventional surgeries and experimental and conventional treatment relating to thoracic disorders with an emphasis upon emphysemic disorders;
- b) to assist individuals in qualifying for experimental surgeries and treatments described in (a).
- c) to locate additional sources of funding for individuals in need of experimental and conventional treatment described in (a).
- d) to assist individuals in applying for additional funds required for experimental and conventional treatment described in (a).

## FOURTH

No substantial part of the activities of the corporation shall be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

#### FIFTH

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

## SIXTH

The non-profit corporation shall have members and shall be managed by a Board of Directors whose appointment and terms of office shall be in accordance with the by-laws of the foundation.

## SEVENTH

#### FOURTEENTH

## PIPTEENTH

This certificate of incorporation may be amended in the manner provided by the Statutes of the State of Idaho at the time of amendment.

## SIXTEENTH

In the event of liquidation, dissolution or winding up of the corporation, whether voluntary, involuntary or by operation of law, any disposition made of the assets of the corporation shall be such as is calculated to carry out the objects and purposes for which the corporation is formed.

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational,

religious or scientific purposes as shall at that time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States of America Internal Revenue Law) or (b) by corporate contributions which are not deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States of America Internal Revenue Law) as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the District Court of the County in which the principal place of business of the corporation is then located exclusively for such purposes or to such organization or organizations as that Court shall determine which are organized and operated exclusively for such purposes.
