- I. Name of Corporation:** The name of the corporation is HBL Corporation.
- II. Period of Duration:** The period of its duration is perpetual.
- III. Corporate Purposes:** The purpose of the corporation is to transact the business of all lawful activity which a corporation may conduct under the laws of the State of Idaho.
- IV. Authorized Shares:** Authorized Capital. The total number of shares that the corporation is authorized to issue is 80,000,000 shares divided into two classes. The designation of each class and the number of shares of each class are as follows:
- a. Common Stock: 60,000,000 shares with par value .0001 per share
 - b. Preferred Stock: 20,000,000 shares of non par value each

The preferred shares may be issued in one or more series. The board of directors may determine the designation, total number of shares, preferences, limitations and relative rights, within the limits set forth in Section 30-1-602 of the Idaho Business Corporation Act, of each of the series of Preferred Stock before the issuance of any shares of that series. Before issuing any shares of a series created under Section 30-1-602 of the Idaho Business Corporation Act, the corporation must deliver to the Secretary of State for filing articles of amendment, which are effective without shareholder action, that set forth the requirements established in Section 30-1-602 of the Idaho Business Corporation Act. As to each such series, the board of directors may, within the limits and restrictions stated in the board resolution originally fixing the number of shares, increase or decrease the number subsequent to the issuance of shares of that series; provided, however, that in no event shall the board of directors decrease the number of shares of such series below the number of such shares then outstanding.

- V. Registered Agent and Address:** The address of the corporation's initial registered office is 2160 S. Twin Rapid Way, Boise, Idaho 83709. The name of its official registered agent at such address is Robert C. Montgomery, Chtd.

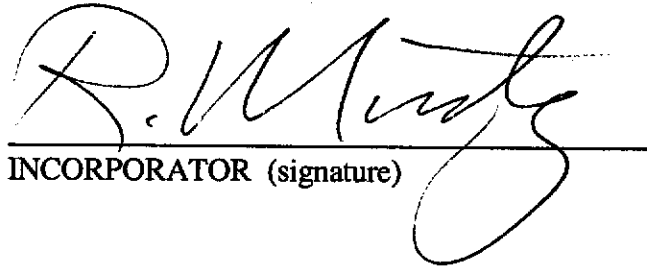

Liability of Directors and Officers: The personal liability of a director or officer to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director or officer is hereby eliminated and no director or officer shall have personal liability to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director or officer, except that the personal liability of a director or officer to the corporation or its stockholders for any breach of the director's or officer's duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law shall not be eliminated and the personal liability of a director or officer to the corporation or its stockholders for the liability imposed by the Idaho Business Corporation Act shall not be eliminated and the personal liability of a director or officer to the corporation or its stockholders for any transaction from which the director or officer derived a legally improper personal benefit shall not be eliminated. The corporation is authorized to enter into a hold harmless and indemnification agreement with each officer, director and person providing professional services or advice to the corporation.
