- I. Name of Corporation: The name of the corporation is HBL Corporation.
- II. Period of Duration: The period of its duration is perpetual.
- III. Corporate Purposes: The purpose of the corporation is to transact the business of all lawful activity which a corporation may conduct under the laws of the State of Idaho.

Before issuing any shares of a series created under Section 30-1-602 of the Idaho Business Corporation Act, the corporation must deliver to the Secretary of State for filing articles of amendment, which are effective without shareholder action, that set forth the requirements established in Section 30-1-602 of the Idaho Business Corporation Act. As to each such series, the board of directors may, within the limits and restrictions stated in the board resolution originally fixing the number of shares, increase or decrease the number subsequent to the issuance of shares of that series; provided, however, that in no event shall the board of directors decrease the number of shares of such series below the number of such shares then outstanding.
