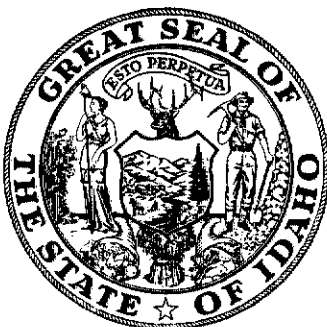

OF

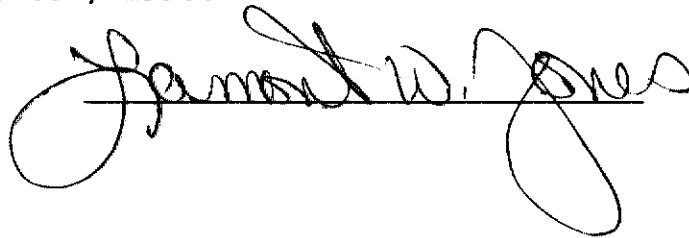
