

The Certificate of Organization of Elevate Academy East Idaho, LLC is to include the following:

Add a new Section 6:

Six

Elevate Academy East Idaho, LLC is organized exclusively for charitable, scientific, literary, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or corresponding provisions of any subsequent federal tax laws, including the operation of a public charter school under the laws of the State of Idaho.

Add a new section 7:

Seven

Upon the dissolution of Elevate Academy East Idaho LLC, the assets of the LLC will be distributed under the direction of, and to the extent determined by, the Sole Member for one or more exempt purposes in accordance with Idaho Code 33-5212 and the Internal Revenue Code as it applies to charitable organizations, or any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
