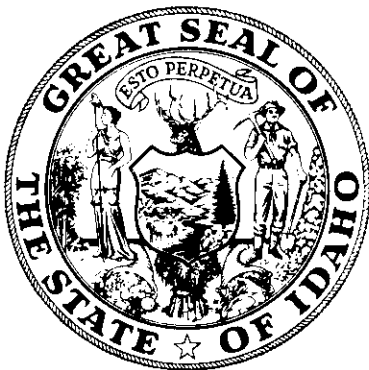

ARTICLES OF AMENDMENT
OF
WORLD MARKETING CONSULTANTS, INC.

Pursuant to Section 30-1-58 of the "Idaho Business Corporations Act" of the State of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I.

The name of the Corporation is "WORLD MARKETING CONSULTANTS, INC.".

ARTICLE II.

The following amendment of the Articles of Incorporation was adopted by the directors of the Corporation on the 23rd day of October, 1983, in the manner prescribed by the laws of the State of Idaho, and the Articles of Incorporation of the Corporation:

"RESOLVED that the Articles of Incorporation of WORLD MARKETING CONSULTANTS, INC., shall be, and the same hereby are amended by striking the words: 'That the name of the Corporation shall be WORLD MARKETING CONSULTANTS, INC.' from Article I thereof and by adding the words: 'That the name of the Corporation shall be WMC INDUSTRIES, INC.'.

ARTICLE III.

No shares of the Corporation are now outstanding.




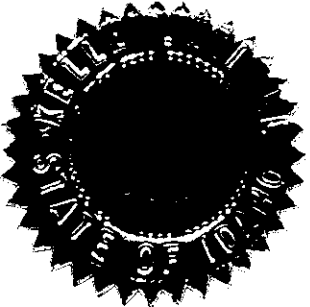
