We, the undersigned persons, acting as the Incorporators of a corporation under the provisions of Title 30, Chapter 3, of the Idaho Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation for such incorporation:

ARTICLE I

The name of the corporation shall be: CHI ALPHA CHRISTIAN FELLOWSHIP AT THE UNIVERSITY OF IDAHO INCORPORATED

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The corporation is organized exclusively for educational, charitable, and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any further United States Internal revenue law. Consistent with and subject to its qualification under Section 501(c)(3), the corporation is organized to do any lawful activity permitted under the laws of the State of Idaho.

ARTICLE IV

The corporation shall have all powers granted by law necessary and proper to carry out its above-stated purposes, consistent with its qualification under Section 501(c)(3).

ARTICLE V

Provisions for the regulation of the Internal affairs of the corporation shall be set forth in the Constitution and Bylaws.

ARTICLE VI

The corporation shall have no voting members.

ARTICLE X

Amendments to these Articles of Incorporation may be made at any annual or special meeting of the board of directors, and must be made in the following manner:

Amendments shall be adopted at a meeting of the board of directors upon receiving the vote of a majority of the directors in office. Any number of amendments may be submitted and voted upon at any one meeting.

ARTICLE XI

In the event that this corporation ceases to function as an Assemblies of God Ministry or is dissolved for any reason, its assets shall be distributed to The Northwest District Council of the Assemblies of God, d/b/a Northwest Ministry Network, 35131 SE Douglas Street, Suite 200, Snoqualmie, Washington, 98065, provided it qualifies at such time for exemption as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or a successor statute. In the event that the Northwest Ministry Network does not so qualify, then the assets of this corporation shall be distributed to The General Council of the Assemblies of God, Springfield, Missouri, provided it qualifies at such time for exemption as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or a successor statute.
