**Articles of Incorporation
Potlatch Timbersports, Incorporated**

We the members of the Potlatch Timbersports, Incorporated, of Potlatch, Idaho the majority of which member are residents of the State of Idaho, have banded together for the benevolent, civic and social purposes, not in any manner for profit, and after due notice having been posted and published do voluntarily associate together for the purpose of forming a corporation under the terms and provisions of the Idaho Nonprofit Corporations Act and Idaho Unincorporated Nonprofit Associations Act of 1997, set forth Articles of Incorporation as follows:

FIRST

The name of this corporation shall be **Potlatch Timbersports, Inc.** of Potlatch, Idaho.

SECOND

The purpose of this corporation is for the advancement of civic, moral and social interests of the community through educational awareness and involvement activities in the following areas, which will include but shall not be limited to; agriculture, forestry, natural resources and other related science areas. The advancement of the aforementioned practices shall be pursued through not for profit community activities which may include, but shall not be limited to the purchasing and or maintaining of community building or buildings or properties for community use, to own or lease real or personal property for the community and civic use. The community obligations pertaining to the community, County, State and Nation. All to be without profit to the corporation or its members.

THIRD

The principle office of and for Potlatch Timbersports, Inc., and the place where the business of this organization will be transacted shall be the City Hall of the City of Potlatch, Latah County, Idaho. The initial registered agent at this office shall be Ben Koester. The registered office will be located at the City Hall of Potlatch on the corner of Main and Sixth Street, Post Office Box 176, Potlatch ID 83855.

FOURTH

Potlatch Timbersports, Incorporated shall not issue capital stock. Membership in this corporation is without money value, and is not transferable. Acceptance to membership in Potlatch Timbersports, Incorporated shall and does constitute membership in this corporation. Proof of acceptance of membership can and shall be verified upon placing of any persons name under the Journal of Members of Potlatch Timbersports, Incorporated. A membership in the Potlatch Timbersports, Inc. shall and does constitute one share and such shares do carry one vote at any and all corporate meetings. The Journal of Members shall be the official register of shares.

FIFTH

The business of Potlatch Timbersports, Incorporated shall be carried and conducted by a board of directors consisting of eight members. This said board of directors shall consist of a President, Vice President, secretary and treasurer and four directors. The directors shall be elected annually from the membership of Potlatch Timbersports, Incorporated during the annual meeting to be held during the third week of October, at the City Hall of the City of Potlatch, Latah County, Idaho.

SIXTH

During a meeting of the Potlatch Timbersports hereafter to be know as Potlatch Timbersports, Incorporated held at the City Hall of the City of Potlatch, Latah County, Idaho on Wednesday the tenth day of February 1999, at which meeting a majority of the organization said club were present, notice of said meeting having been posted on the front door of the City Hall of the City of Potlatch, Latah County, Idaho from January 27th, 1999 through February 10th, 1999 (to be marked as exhibit "A") and having been published in the Ad Mart a advertising newspaper of weekly publication in the Latah County, Idaho and Whitman County, Washington from January 27th, 1999 through February 10, 1999 (to be marked as exhibit "B"); that at said meeting the following members of the Potlatch Timbersports, Incorporated were elected as directors until the next year ending annual meeting.
