Independent Wholesalers, Inc. is authorized to issue one class of capital stock identified as "common stock". On February 27, 1967

R. J. McCaslin & Son Lumber Co., an Idaho corporation, was the owner and holder of all of the issued shares of common stock of Independent

Wholesalers, Inc. and was the only party entitled to notice of a meeting of the shareholders of Independent Wholesalers, Inc. called for the purpose of amending the Articles of Incorporation of Independent Wholesalers, Inc. in the respect herein set forth. On February 27, 1967, by instrument in writing duly signed on behalf of R. J. McCaslin & Son Lumber Co., the Articles of Incorporation of Independent Wholesalers, Inc. were amended to change the name thereof to McCaslin's, Inc. and, accordingly, Article I of the Articles of Incorporation of Independent Wholesalers, Inc. was thereby amended to read as follows:

"ARTICLE I

That the name of this corporation shall be:
