The undersigned, acting as the incorporators of a corporation ("Corporation") organized under and pursuant to the Idaho Business Corporation Act, Chapter 1, Title 30, Idaho Code ("Act"), adopt the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME

The name of the Corporation shall be TECHNOLOGY TRANSFER MANAGEMENT, INC.

ARTICLE II. PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III. INITIAL REGISTERED OFFICE AND AGENT

The address of the Corporation's initial registered office is 8852 West Trayis Ridge, Pocatello, Idaho 83201, and its initial registered agent at such address is William E. Jahsman.

ARTICLE IV. PURPOSES

The Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE V. STOCK

The total number of authorized shares of the capital stock of this corporation is 5,000 shares of common stock, all of which shall be without nominal or par value, nonassessable, and of the same class. Such stock may be issued from time to time without

action by the stockholders for such consideration as may be fixed from time to time by the Board of Directors, and such shares so issued, the full consideration for which has been paid or delivered, shall be deemed fully paid stock and the holder of such shares shall not be liable for any further payment thereon.

ARTICLE VI. BOARD OF DIRECTORS

The initial Board of Directors shall consist of the following persons who shall serve as directors until the first annual meeting of shareholders, or until their successors be elected and qualified:

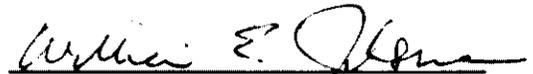
