ARTICLES OF INCORPORATION of "THE ~~IDEAS~~ ^{WESTERN} COMMISSION COMPANY."

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona fide residents and citizens of the State of Idaho, have this day voluntarily associated ourselves for the purpose of forming a corporation, under the laws of the State of Idaho.

And We Certify,

First. That the name of said corporation is "THE ~~IDEAS~~ ^{WESTERN} COMMISSION COMPANY." *limited*

Second: That the purposes for which it is formed are:—To engage in and transact a general commission business.

Third:—That the place where its principal business is to be transacted shall be Pocatello—Bannock County State of Idaho.

Fourth:—That the term for which it is to exist is Fifty years, from ~~January 1st~~ and after the date of its incorporation.

Fifth:—That the number of its Directors shall be three, and that the names and residences of those who are appointed for the first year are:—
