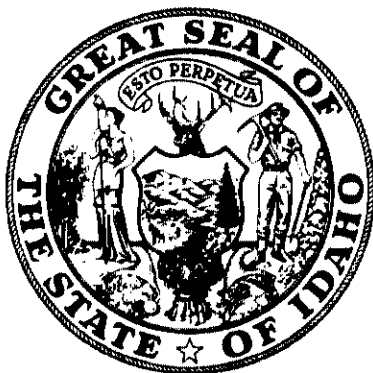

ARTICLES OF INCORPORATION

1. **NAME:** North American Biodynamic Research Institute, Inc.
2. **STATUS:** This corporation shall be a non-profit corporation governed by the laws of the State of Idaho.
3. **DURATION:** The period of duration shall be perpetual.
4. **PURPOSE:**
 - a. To develop and standardize courses of instruction in the quantum physics aspects of healing.
 - b. To encourage and conduct scientific research dealing with the quantum physics aspects of healing.
 - c. To develop and distribute text books dealing with the quantum modes of healing.
 - d. To provide a central library of reference materials dealing with quantum physics and healing. within the QUANTUM scope.
 - e. To provide courses of instruction to professionals who are establishing specialties within the quantum scope.
 - f. To assist in establishing specialty boards for the purpose of certifying competency practitioners practicing specialties related to the quantum modes of healing.
 - g. Other needs relating to the quantum mode of healing as the above stated purpose and officers may see fit to promote from time to time.
 - h. The property of the corporation is irrevocably dedicated to the above stated purposes and upon the dissolution or winding up of the corporation its assets remaining after payment of, or provisions for payment, of all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, religious, literary, and/or scientific purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code.

5. **MEMBERSHIP:** This corporation shall have one class of membership. Membership may be extended under the following consideration:
- a. It shall consist of those individual who are providing the start-up funding.
 - b. Individuals or organizations who provide significant additional funding may be considered for membership.
 - c. Individual who possess technical skills needed in order to make the various programs function may be considered for membership.

6. **CERTIFICATES:** This corporation shall issue stock certificates to those individuals or organizations who:

- a. Are in category 5a for their initial investment,
- b. May issue stock certificates to individuals in categories 5b and c above at the discretion of stockholders in category 5a.
