ARTICLES OF INCORPORATION
OF
3 - S, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST

The name of the corporation is 3-S, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) consisting of one class only of common stock, with a par value of one dollar (\$1.00) per share.

FIFTH

Provisions for the regulation of the internal affairs of the corporation are as set forth in the By-laws.

SIXTH
