ARTICLES OF INCORPORATION
OF
CAPITOL AUTO RENTAL, INC.

We, the undersigned natural persons all over the age of twenty-one years and citizens of the United States acting as incorporation under the Idaho Corporation Laws, adopt the following Articles of Incorporation;

ARTICLE I.

The name of this corporation is Capitol Auto Rental, Inc. its duration shall be perpetual.

ARTICLE II.

This Corporation may engage in any commercial, industrial, financial and agriculture enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho; further, in pursuance of such corporation purpose, this corporation may manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, lease, assign, and transfer or otherwise dispose of, invest, trade, transport, and deal with, goods, wares, services and merchandise and real and personal property of every class and description.

In general and in connective with the foregoing, said corporation shall have and excise all of the powers conferred under the laws of the State of Idaho, upon business corporations, and each and everything necessary, suitable or advisable for the accomplishment of the foregoing objects, or which at any time appear to be conclusive to or expedient for the benefit of said corporation in connection therewith.

ARTICLE III.

The location and Post Office address of the registered office of this corporation in the State of Idaho is 1017 Jefferson street, Boise, Idaho.

ARTICLE IV.


