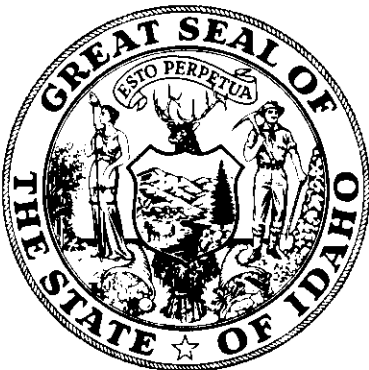

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, having been duly elected Trustees of the Post Falls Christian Church of Post Falls, Idaho, and in pursuance of our election, do hereby associate ourselves and the other members of said church, together for the purpose of forming a religious non-profit corporation under the following articles:

ARTICLE I NAME

The name of this corporation shall be Post Falls Christian Church, Inc.

ARTICLE II PURPOSE

Section I

The purpose of this corporation shall be the establishment and maintenance of the Post Falls Christian Church and to own and maintain property necessary to its functions, the establishment of other sister churches and such other organizations which are customary and suitable for religious worship, religious training, and the dissemination of the teachings of the Holy Scriptures.

Section II

This corporation is organized exclusively for religious, charitable, scientific, literary, or education purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code. This organization is not organized for profit.

ARTICLE III REGISTERED OFFICE

The principal place for the transaction of the business of this corporation shall be Post Falls, Kootenai County, State of Idaho. Its initial office is located at 1715 N. William, Post Falls, Idaho, and the agent of that address is Robert L. Brown, member.

ARTICLE IV TERM

The corporation shall exist for a perpetual period of time.

ARTICLE V MANAGEMENT

Section I

This corporation is a church and the management of its affairs is vested in its members pursuant to section 30-314 (c) Idaho Code.

Section II

The membership shall have power to make such prudential By-Laws as the corporation shall deem proper for their own government and the government of the corporation and management of its affairs.

Section III Trustees

a. This corporation shall have a minimum of three trustees.

b. The initial trustees of this corporation are Claire Boulton, N. 4616 St. Charles Road, Spokane, Washington, 99216; Robert L. Brown, 1715 N. William, Post Falls, Idaho 83854; Samuel M. Presise, 1990 Prairieview Drive, Post Falls, Idaho 83854; Alvin Revik, N. 4005 Chase Rd, Rathdrum, Idaho 83858; and L. R. Van Dusen, E. 11918 Fairview, Spokane, Washington, 99206; and they shall hold their respective offices for one year or until their successors are duly elected and qualified.

c. The term of office for trustees of this corporation shall be for a period of three years. First elected term shall be for 1, 2, and 3 years respectively.

d. Authority of the Trustees is expressly limited to carrying out such responsibilities as shall be assigned to them by the membership.

Section IV Church Board and Other Officers

The membership of this corporation shall have power to establish such boards and offices as it shall consider necessary and good for the governance of the corporation, to elect such other officers as it may desire, and to delegate such authority as it deems proper.

Section V

No part of the net earnings or assets of the corporation shall inure to the benefit of, or be distributable to, its members or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

Section VI

The private property of the members and officers of this corporation shall not be subject to the corporate debts of the corporation.

ARTICLE VI MEMBERSHIP

Membership in this corporation shall be established in accordance with the provisions and criteria contained in the New Testament of the Holy Bible.

ARTICLE VII DISSOLUTION

Upon dissolution of the corporation, the Trustees shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code, as the membership of the corporation shall have determined.

ARTICLE VIII AMENDMENT

The Articles of Incorporation of this corporation may be amended at any regular meeting, or at any special meeting of the member thereof called for that purpose, by the affirmative vote of two-thirds (2/3) of the members present and voting at such meeting, provided that the proposed amendment shall be submitted in writing by the secretary to the membership at least thirty (30) days prior to the meeting at which it is to be considered.
