



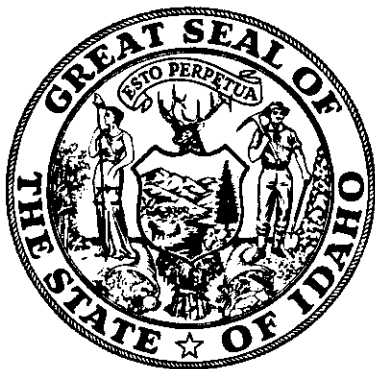

KNOW ALL MEN BY THESE PRESENTS:

That pursuant to the provisions of the Idaho Code, Section 30-1-75, GARNAND MARKETING, INC., an Idaho Corporation, by and with unanimous consent of its shareholders, makes these articles of merger this 28<sup>th</sup> day of June, 1985,

1. The name of the subsidiary corporation to be merged is Garnand Produce, Inc. (herein the "subsidiary corporation") and the corporation owning 100% of the shares of the subsidiary corporation is Garnand Marketing, Inc. (herein the "surviving corporation").
2. The manner and basis of converting the shares of the subsidiary corporation shall be to merge the cash and other property into the assets of the surviving corporation.
