

ARTICLES OF INCORPORATION.

The Twin Falls Telephone Company, Limited.

Know all men by these presents: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify: - -

I.

That the name of said corporation is, The Twin Falls Telephone Company, Limited.

II.

That the purposes for which it is formed are to build construct, hold, own, lease, maintain, acquire and operate telephone lines in the State of Idaho; and to acquire, use and hold the real-estate necessary therefor; and to acquire, hold and use rights, franchises and privileges in connection with said telephone lines.

That it is the purpose and object of this corporation to acquire the telephone lines now constructed, or in process of construction, running from Blue Lakes to Twin Falls, Milner and Kimama; and also to build, own, lease, acquire, hold and operate telephone lines from Twin Falls to Hagerman, and from Twin Falls to Rock Creek and to such other points as may hereafter be decided on by the corporation.

III.

Said telephone line is to be constructed of poles and wire and to use the customary equipment now in use, or such machines or devices as may hereafter come into practical use for transmitting the voice or transmitting signals.

Said telephone line is intended to run from Blue Lakes to Twin Falls, thence to Milner and thence to Kimama; also

from Twin Falls to Rock Creek, and from Twin Falls to Hagerman - the estimated length being one hundred and five miles.

IV.

The place where its principal business is to be transacted, is Blue Lakes, Lincoln County, Idaho.

V.

The term for which it is to exist is fifty years.

VI.

The number of its directors shall be five; and the names and residences of those appointed for the first year are as follows: :
