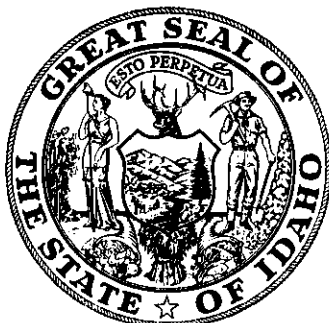
CERTIFICATE OF AMENDMENT OF

RESTATEMENT OF ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, DELMAR A. ORSER and BONNIE S. ORSER, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho. That the number of shares of each class entitled to vote on the amendment is 250 and 250 shares voted for the amendment. All articles are amended. We do hereby certify:

ARTICLE I:

The name of this corporation shall be:
"D. ORSER INCORPORATED"

ARTICLE II:

The duration and existence of this corporation shall be perpetual.

ARTICLE III:

The purposes for which this corporation are formed are as follows:

To engage in the printing business and all forms of reproduction of the printed word and documents. To acquire by purchase or lease or otherwise, lands and interest in lands and tenements; to own, hold, improve, develop and/or manage any real estate; to erect or cause to be erected on any real property buildings or other structures with their appurtenances; to rebuild, enlarge, or alter or improve any buildings or other structures now or hereafter erected on any real property, to manage, sell, lease, deed in trust or otherwise dispose of and deal in real property and any interest therein and in buildings or other structures, and any stores, shops, suites, rooms or parts of any buildings or other structures, restaurants and water rights, to acquire unimproved real estate for development and subdivision, principally for construction of housing or for resale to others, for such construction or for use as mobile home sites, to borrow money for corporate purposes and to issue therefor evidences of indebtedness, including but not limited to, bonds, notes and debentures.

ARTICLE IV:

That the location of the registered office of the corporation is 300 E. Harrison, Coeur d'Alene, Idaho, and the mailing address is Post Office Box 337, Coeur d'Alene, Idaho. The registered agent at said address is Delmar A. Orser.

THAT THE TOTAL AUTHORIZED STOCK OF THE CORPORATION SHALL BE \$500,000.00, divided into 200 voting shares valued at \$2,500 per share. All stock shall be of the same class. This article was amended November 12, 1993, and is incorporated into the restated articles of incorporation.

ARTICLE VI:

That the only authorized stock will be the common stock of the said corporation with equal rights, preferences and restrictions.

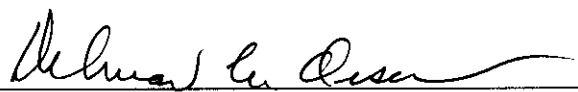

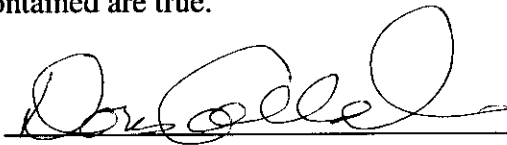
