# ARTICLES OF INCORPORATION

of

# INTERMOUNTAIN LOGGING CONFERENCE, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, MAX TRIPP, BLAINE BLOOMGREN, EDWARD L. SHULTS, ROBERT S. NOBIS, HENRY A. ARD, and C. CLAYTON WIMER, all of whom are of legal age and citizens of the United States, have this day associated ourselves and do hereby and by these Articles of Incorporation unite and associate ourselves for the purpose of forming a corporation under Title 30, Chapter 10, Idaho Code, and we hereby acknowledge, enter into, and adopt the following Articles of Incorporation.

#### ARTICLE I.

The name of this corporation shall be INTERMOUNTAIN LOGGING CONFERENCE, INC.

### ARTICLE II.

The period of the duration of this Corporation shall be perpetual.

## ARTICLE III.

The location and Post Office Address of the registered office in the State of Idaho shall be 916 Foster Avenue, Coeur d'Alene, Kootenai County, Idaho.

## ARTICLE IV.

In furtherance and not in limitation of the general powers conferred by the laws of the State of Idaho, this Corporation shall have the following purposes and powers: 1. To determine and encourage the use of good forestry practices and to establish and improve logging standards and methods, which will result in a more sound management of the investment of the industry and in the conservation of forest resources for present and future use.

- 2. To provide for and encourage the interchange of ideas of mutual interest to Conference members through meetings and programs.
- 3. To promote a spirit of friendship and cooperative effort among its members.
- 4. To conceive and promote such programs and activities of employee training, logging equipment demonstrations and research, public relations, forest conservation and protection, as will best serve or meet the needs of the forest industries.
- 5. To conduct these activities and achieve these objectives without pecuniary profit.
- 6. To do everything and anything reasonably necessary, suitable, proper, convenient, or incidental to the aforesaid purposes or which properly may be done by the corporation under the laws of the State of Idaho, and to possess all proper powers, rights and privileges permitted to such a corporation by such laws.
- 7. The foregoing statement of corporate purposes shall be construed as a statement of both purposes and powers, and not as restricting or limiting in any way the general powers of this corporation, or their exercise and enjoyment, as they are expressly or impliedly granted by the laws of the State of Idaho.

### ARTICLE V.

Corporations, associations and copartnerships, as well as persons, may become members of this corporation subject to any restriction thereof by the Constitution or laws of the State of Idaho.

# ARTICLE VI.

The rights and interests of all members shall be equal, and no member can have or acquire a greater interest than any other member. Membership certificates shall be issued to each member and shall not be assignable. No membership shall be granted nor any membership certificate transfer approved except by resolution of the Board of Directors and under such regulations as may be prescribed by the Bylaws.

#### ARTICLE VII.

The area to be served by this corporation shall be confined to that area lying east of the Cascade and Sierra Mountains, and included in the States of Oregon, Washington, California, Idaho, Montana, North and South Dakota and Wyoming and Provinces of the Dominion of Canada.

#### ARTICLE VIII.

# Dissolution

In the event of the dissolution of this corporation, any of its assets not required by law to be otherwise applied or distributed shall be distributed as follows:

- 1. The Board of Directors may direct that such assets be distributed to any successor or other organization having purposes similar to the purposes of this corporation.
- 2. The Board of Directors may direct that such assets be distributed to the schools of forestry located in the area served by this corporation in such proportions and for such educational purposes as the Board of Directors deems appropriate.
- 3. In the absence of any such direction, such assets shall be distributed in equal shares to the schools of forestry accredited by the Society of

American Foresters located in the area served by this corporation, to be used by such schools to provide scholarships for students of forestry.

#### ARTICLE IX.
