## ARTICLES OF AMENDMENT OF NW SERVICES, INC.

- 1. The current name of the Corporation is NW Services, Inc. and it is a corporation existing under the laws of the state of Idaho.

Purpose - The purpose for which the Corporation is organized is:

The primary purpose of the Corporation is to contribute to world peace and understanding, building friendships and families globally. This purpose is to be reached by providing programs which focus on cultural exchange through services and education. This is called the PEACE (Promoting Educational And Cultural Exchanges) program. It is a high school level international exchange program offering a semester, academic year or short term stay in another country. Students live with volunteer host families. It is offered for American and foreign students. NWS PEACE program is designated and approved by the federal State Department.

The amendments were adopted by the Board of Directors on the 20<sup>th</sup> day of January, 2007.

The Board of Directors has the authority to amend the Articles of Incorporation and the Board of Directors voted unanimously to amend the Articles of Incorporation as set forth above.

The Corporation has no members and all members of the Board of Directors voted affirmatively for the amendments contained herein.
