ARTICLES OF INCORPORATION OF RECEIVED
THE COEUR D'ALENE IN AND OUT, INC. SEC. OF STATE

WE, THE UNDERSIGNED, being of full age and citizens of the United States or of its territories or possessions, have this day, voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt ARTICLES OF INCORPORATION, as follows:

ARTICLE I

NAME

The name of the corporation is THE COEUR D'ALENE IN AND OUT, INC.

ARTICLE II

PURPOSES

The purposes of the corporation are to acquire, operate, and manage business property including restaurants and to conduct any and all other lawful business and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE III

DURATION

The duration of the corporation is perpetual.

ARTICLE IV

LOCATION
