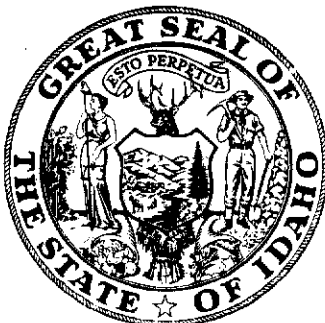

ARTICLES OF INCORPORATION

of

JWM, Inc.

The undersigned, acting as incorporators under the provisions of the Idaho Business Corporations Act, adopt the following **Articles of Incorporation**.

NAME

The name of the corporation is JWM, Inc.

DURATION

The period of its duration shall be perpetual.

PURPOSES

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, and its initial business activity shall consist primarily of retail sale of beverages and entertainment.

STOCK

The corporation shall have the authority to issue ten thousand (10,000) shares of capital stock, all of one class, with each share having no par value. The corporation is a "Small Business Corporation" under provisions of the Internal Revenue Code, and the stock is "Section 1244 Stock."
